

What is Evidence-Based Practice (EBP)?

EBP is a **problem-solving process** that incorporates the best **scientific evidence**, **clinical expertise**, **and patient preferences**.







Why Use EBP?

- New research findings provide evidence for safer, more efficient, cost-effective, patient-centered nursing practice
- Improves healthcare and clinical outcomes.






Johns Hopkins EBP Model Translation and Action Planning Tool v.2022



TSNRP EBP Facilitators

Mentor and coach nurses through the EBP process:

- EBP Facilitator consult is required to apply for TSNRP Mini EBP Award
- Identify or address clinical problems.
- Develop a searchable PICO(T) question.
- Review and synthesize published literature.
- Select appropriate outcome measures.
- Analyze and evaluate outcomes.
- Share results of EBP changes (conferences, posters, published articles).



- Mini EBP awards = Up to \$10,000
- TSNRP EBP Awards = \$250,000

TSNRP Mini EBP Award Checklist

- Write clinical problem for inquiry.
- Consult local contact(s) and mentor(s).
- Advise TSNRP Grants of intent to apply.
- Consult with assigned EBP Facilitator.
- Download guide/forms from TSNRP Grants Portal: www.tsnrpgrants.com/ords/f?p=100
- Assemble team/stakeholders and assign roles.
- Draft and review PICO(T) question(s).
- Consult medical librarian, site experts, and EBPF to review current best practices.
- Draft timeline of milestones (Gantt chart or similar).
- Obtain letters of support for assistance needed for the project (e.g., IT, unit, director, space, engineering, etc.).
- Create budget (line item for final with S/H/tax).
- Compile evidence appraisal and synthesis tables.





TSNRP Mini EBP Award Checklist cont'd

- Identify outcomes and measurement tools to be used.
- Develop project summary (TSNRP and/or DHA focus areas, military nursing relevance, sustainment plan).
- Submit project to eIRB. (DHA guidance states EBP must submit to eIRB review).
- Confirm contact(s) (email & phone) for project related questions from TSNRP.
- Verify contact(s) shipping address and phone number for equipment delivery.
- Conduct final review with mentor(s) and EBPF before submission to TSNRP.
- Submit application submission and receive email confirmation receipt.
- Follow up quickly with any requested stipulation items or questions.
- Send confirmation email upon receipt of award equipment, and track condition and location for inventory reporting.
- Complete and submit Interim and Final Reports.
